Fire Administration Suggests Ways to Maintain First Responder Capabilities During a Pandemic

During a severe pandemic, workloads for first responders will increase and staff sizes will diminish as employees and their families become ill. To help support contingency planning, the U.S. Department of Homeland Security (DHS) and the U.S. Fire Administration issued the report Information for *First Responders on Maintaining Operational Capabilities During a Pandemic* (November 2010).

The report, in conjunction with the DHS *Pandemic Influenza Best Practices and Model Protocols* (2007), is intended to support first responder efforts to provide the best service to their team and their community. The report shares

- Potential ways to adjust operations to maintain readiness and response
- Opportunities, including two planning tools, for leaders in the first responder community at the local level to take action

➤ Reference sheets with discipline-specific potential action steps.

The report also offers suggestions for staffing, training, workforce protection, sustainability, resource sharing, and public communication and education for law enforcement, fire service, emergency services, and emergency call centers.

Report Offers Advice on Using Microcredit for Disaster Recovery

Disasters, whether natural, accidental, or intentional, pose one of the greatest threats to any economy. Historically, the small business community is the hardest hit. A new report documents a study to determine the potential for using microcredit as a disaster relief tool. Idaho Newsletter Keeps Emergency Managers Up to Date

Each quarter, the Idaho Bureau of Homeland Security publishes a newsletter on emergency management topics such as lessons learned from disasters, progress on major initiatives, and tools for emergency planning. Version 2.0 of the Private Sector Resources Catalog Now Available

In November 2010, DHS issued Version 2.0 of its *Private Sector Resources Catalog* to facilitate access by businesses to homeland security resources. First issued last May, the catalog collects the training, publications, guidance, alerts, newsletters, programs, and services available to the private sector across DHS components.

DHS had committed to updating the catalog as resources changed. The <u>full catalog and various</u> chapters are available online.

Center Offers Funded Training to Emergency Responders

Established in 1998, the Center for Domestic Preparedness (CDP) trains emergency response providers in preparedness, protection, and response. Costs for training, transportation, meals, and expenses are fully funded by DHS for state, local, and tribal responders. International, federal, and private sector responders may participate in CDP training on a space available, fee-for-service basis.

The CDP's interdisciplinary resident and nonresident training courses promote greater understanding of emergency management, emergency medical services, fire service, governmental administrative, hazardous materials, healthcare, law enforcement, public health, public safety communications, and public works. Team training for two to fifty people from the same organization is also available.
